KITTY TERMS AND CONDITIONS OF SALE CONTRACT

The sale of a male/female: Maine Coon Kitten/Cat:

The purpose of this agreement/contract is to ensure that the kitten/cat being purchased is protected and that both parties (Buyer and Seller) agree with the terms and conditions as set out in this agreement/contract. The Buyer is the person listed above. The Seller is Paws Plus Claws.

It is the responsibility of The Buyer to be aware of these terms and conditions prior to payment of the deposit. The Buyer has read, and by signing this agreement/contract, understands the information in the agreement/contract and agrees to be bound by the terms and conditions of the agreement/contract:

1. The Seller has selected the parentage of the kitten/cat for health, temperament and type for the betterment of the breed.
2. The Seller has given the kitten/cat all necessary care. The kitten/cat has been vaccinated, immunised, wormed, microchipped and de-sexed prior to sale. The kitten/cat has been checked by a veterinary surgeon and is free from infectious diseases. The Seller is not responsible/liable for any genetic issues.
3. All paperwork from the veterinary surgeon, pedigree papers and any other documents relating to the kitten/cat will be given to The Buyer on collection. If any papers have not been received by The Seller at time of collection of the kitten/cat by The Buyer, they will be forwarded to The Buyer at the address provided above.
4. The Buyer understands that as a registered breeder (QFA Queensland Feline Association Registration Number: QFA21(ANCATS) 49202(s)) The Seller complies with the Code of Ethics as set out by Queensland Feline Association.
5. All health care will be the sole responsibility of The Buyer upon collection/transport of the kitten/cat.
6. The Buyer understands and agrees that the kitten/cat is their legal responsibility upon collection.
7. If we hear that one of our kittens/cats has being mistreated in any manner, it will be reported to the RSPCA as we do not promote, support or allow animal cruelty to our kittens/cats whatsoever.

8. The Buyer is to ensure that the kitten/cat is to remain inside their home or in a suitable enclosure unless on a leashed walk.
9. It is preferred not to leave the kitten/cat alone for periods longer than six hours to prevent distress/anxiety in the kitten/cat.
10. If re-homing is required, The Buyer can call The Seller for help in rehoming the kitten/cat.

Social Media/Legal

1. If a disagreement or legal proceedings occur between The Buyer and The Seller as stated at the top of this agreement/contract, both parties are prohibited from discussing the proceedings with anyone by any means.
2. Both parties agree it is prohibited to provide any information to any social media pages, including personal social pages.
3. Both parties agree that no party to this agreement/contract will attempt to slander/defame the character of the other party in this agreement/contract and is understood legal proceedings can be brought against the said party.

The Seller reserves the right to refuse the sale of the kitten/cat at any point up to and including the time of collection.

Deposits are **NON-REFUNDABLE**, please ensure you are certain of your purchase before placing any money with the seller.

Both parties of this agreement/contract agree to adhere to the terms and conditions of this agreement/contract once the deposit has been paid.

If you have a kitten/cat which requires transport, all transport and associated costs are borne by The Buyer. Funds will need to be cleared in The Sellers account one week before the departure date.
